Changes to Our Constitution

Crack the

champagne and chill the glasses, after

months of hard work the constitution has been passed by the Ministry of Fair Trading. The changes to the constitution include:-

- the name of the Society shall be the Occupational Health Society of Australia (W.A. Branch) Inc;
- the committee shall maintain a register of the Societies current members;
- upon request to the Hon. Secretary in writing, the incorporated association of records and documents shall be made available for inspection by financial members;
- the constitution shall be altered by the consent of 75% or greater of members voting at a meeting or by the consent of 75% of all valid votes cast in a postal ballot of financial members;
- for dissolution of the Society, the consent of 75% or greater of members voting at a Special General Meeting;
- ✓ upon dissolution the remaining funds will be distributed to another association incorporated under the Associations Incorporation Act 1987 which has objects similar to those of the Society or for charitable purposes. This shall be determined by the resolution of the members when authorising and directing the Committee to prepare a distribution plan for the distribution of the surplus property of the association;

HIV and Aids in the Workplace



The WA AIDS Council is seeking comments and/or support from the Society in relation to concerns they have about Regulation 2.5 of the OSH Regulations.

The Society has received correspondence from the Deputy Chairman of the Council expressing concern that Regulation 2.5 requires WorkSafe WA to be notified in the event that certain diseases are contracted in the workplace or as the result of work.

The Council is concerned that the Regulation includes H.I.V., which allows "the easy identification of health care workers". This undermines the current successful system used by the Health Department of WA, which uses a coding system to identify infected persons thereby maintaining privacy.

The Council are concerned for the privacy of all individuals, not just health care workers and wish to have this Regulation reviewed and possibly amended. REQUIREMENT TO EXERCISE "DUE DILIGENCE"

The Occupational Health and Safety Act of NSW was recently amended to remove a key defence formerly available to directors and managers who were prosecuted under the Act. Previously, directors and managers could avoid liability by demonstrating that an offence occurred without their knowledge of the circumstances of the breach. The revised law now requires directors and managers to demonstrate that they exercised all due diligence to prevent the breach, whether they had knowledge of the breach will no longer be a relevant factor.

Whilst changes to the OHS Act are only in NSW, they are seen as a national benchmark. Thus, as good OSH practice, due diligence requires:

- comprehensive systems to be established and implemented by management;
- 2. training;
- 3. auditing on a systematic basis;
- 4. prompt action on audit reports;
- 5. demonstrable commitment at
- board level to monitor the adequacy and currency of OSH systems applicable to all staff and contractors.

New Compliance Standard

Standards Australia has released a new standard which aims to help corporations meet the requirements regulations. 3806-1998 of "AS Compliance Programs", is а document objective that sets benchmarks for corporations to implement effective compliance programs. The standard is generic & can be used to assist both public and private organisations in developing, implementing & maintaining effective compliance programs in any form of legal, industry or in-house regulatory arrangement.

UV RADIATION FROM QUARTZ HALOGEN DOWNLIGHTS

WorkSafe WA and the Health



Department of WA have highlighted problems associated with employees working under quartz or tungsten halogen

down-light systems.

The high filament temperature produced in these lights and the quartz envelope which transmits the ultraviolet radiation (UVR), results in potentially hazardous UVR emissions from the globe. Excessive exposure of the skin to such lighting can cause sunburn and long term skin cancers ie exposure from desk lamps.

10 minutes exposure to noon time summer solar UVR, is approximately equivalent to the daily exposure limit for general and occupational exposure to UVR. Some brands of unfiltered 50 watt quartz halogen globes, can emit up to this amount of UVR at 25 cm to unprotected skin in about 10 minutes! Recommended practice includes replacing lamps or providing filters for them, educating employees' and providing warning of risk through labelling.

The Australian Dairy Corporation has developed a complete range of up to date materials, aimed at the general public, which are excellent for health promotion initiatives, and come free of charge. Booklets, posters and fact sheets are available for educating adults and children on issues such as dental nutrition, healthy recipes, osteoporosis and healthy bones, the amount of calcium in food guides, lactose intolerance, dairy myths and fallacies and much, much more. Truckie Fatique Regulations and Code



From August, new National Road Transport laws will be introduced to combat driver fatigue amongst truck drivers.

This includes:-

- regulated driving hours to a maximum of 12 hours or 14 working hours per day;
- a maximum of 72 hours driving and/or working in any 7 day period (including a 24 hour rest break).

These laws, however, will not be adopted by WA. The WA Department of Transport and Main Roads is currently developing a code of practice on Fatigue Management, with the final draft of the code expected to be submitted to WorkSafe WA in July, 1998. It is envisaged that an awareness campaign will be implemented and will that the code be fully operational by 1999.

🛛 Holidays 🖌 Your IQ??

According to German academic, Sigfried Lehrl, holidays can reduce your IQ by up to one fifth. Pass times that are usually mandatory on holiday, such as sleeping on he beach, relaxing by the pool or being driven around in a tour bus were found to cause the mind to shut down (wasn't that the objective??). Lehrl states that after just 5 days the IQ is reduced by 5% and after 3 weeks by an amazing 20%. What Lehrl doesn't say, is how long it takes for the IQ to return to normal post returning to work.

GARDEN SOIL A HAZARDOUS SUBSTANCE ???

The Health Department of WA gazetted on March 17th, 1998, the Health Regulations 1998 - HE301, declaring garden soil to be a hazardous substance (Reg. 5). This regulation requires a Schedule 1 warning notice to be displayed on packaging or at point of sale for unpackaged garden soil. A Schedule 1 warning notice states:-



Health Warning" Garden Soils contain microorganisms that may be harmful to your health. Always

wear gloves, keep soil damp whilst in use, avoiding inhaling the mix and wash hands after use.

Garden soil however is not classified as a Hazardous Substance under the WorkSafe WA Regs. According to Reg. 5.2(C), the WA OSH regulations do not apply to a substance that may be hazardous only by reason of its containing any disease causing organism such as Legionella in garden soil/potting mix. However, Section 19 of the OSH Act places a duty of care by the employer to ensure that all packaged goods coming on site were labelled as above and handlers of the packaged goods received appropriate advice to ensure a safe system of work.

Silica A Human Carcinogen

Mr Pat Gilroy. Deputy Chief Executive Officer from the Chamber of Minerals and Energy forwards the Chambers view on their recent Seminar -"Silica - Its current Classification Human as а Carcinogen - Consequences for Employers".

The decision by the Chamber of Minerals and Energy to conduct a public seminar on the 1996 classification by the International Agency for Research on cancer was a logical extension of the industry's health monitoring program. The Chamber has taken an active role in the debate on silica as a carcinogen including participation in international meetings and ongoing research on previous industry employees in underground mining operations.

The decision by IARC to declare silica a human carcinogen was in the Chamber's view highly questionable and this concern was shared with Dr Bruce Armstrong in his keynote address.

The seminar attracted



120 delegates from a range of interests and was enthusiastically received as little

attempt has been made since the decision to appraise affected industries of its impact. Attendees were given a full briefing on all aspects of silica exposure, its consequences and legal implications. The WA mining industry has been free of industrial disease for a quarter of a century and the Chamber is determined to ensure that workplace exposures to respirable silica are minimised to prevent silicosis and in doing so, prevent any possibility of lung cancer being contracted in the mining industry.

"Emergency Incident Risk Management - A Safety and Health Perspective"

Emergency Incident Management is a useful reference text that has been designed to provide information and guidelines for emergency personnel on how to develop and implement comprehensive emergency risk management programmes.

The aims of these programmes are to reduce any harmful exposures that can attribute to on the job fatalities or injuries. The book has been written to ensure that programmes are designed with the intention to minimise both property and equipment damage in the event of an emergency.

The text has been divided into 4 main subject areas:-

Part One : Administration and Organisation

The basics of risk management from an administrative standpoint, including discussion of applicable laws, codes and standards.

Part Two : Comprehensive Risk Management Plan Establishment of a framework for a comprehensive, pre-emergency risk management plan for the organisation.

Part Three : Emergency Incident Risk Management The nuts and bolts of assessing and controlling the risk on the scene of an emergency. *Part Four : Integration* A review of the key components of the book, and how they all tie together.

The strengths of this text are that it is:an easy reading reference text; &

- leach Chapter contains:
 - 🖛 major Goals;
 - lists the key learning points; &
 - suggested methods of implementation.

The biggest weakness of this text is that it is based on American legislation.

Seminar Review - Manual Handling

March '98 saw a mixed bag of participants ranging from OSH professionals, management reps and company personnel attend a challenging seminar presented by the Manual Handling Centre entitled "Successful Workplace Programs". The aim of the seminar was to revisit manual handling (MH) injuries, that still attribute to 30% of all lost time injuries in WA workplaces.

The opening address was presented by the Hon Graham Kierath, the Minister for Labour Relations and followed by speakers from WorkSafe WA, the Chamber of Commerce & Industry and Curtin University. This session tackled legislative initiatives, the latest MH research, risk assessment and why workplaces are not effectively dealing with MH issues.

The afternoon was based on practical MH initiatives and solutions from Hamersley Iron, Sir Charles Gairdner and CSR Construction. These case studies highlighted that a collaborative approach driven via employee involvement was fundamental to the success of the company's MH programmes and strategies.

Overall, this seminar was informative, practical and most of all it challenged us to look further than our own job role as the manager, OSH professional or employee, and to 'step into someone else's shoes' to experience their perspective on MH
